The research will identify solutions to halt biodiversity loss and restore habitats and ecosystem processes.

Responsibilities

- Conduct research in the field of ecophysiology and bioenergetics of marine benthic organisms with the possibility of scientific qualification (PhD).
- Investigate the cumulative effects of interacting stressors, including climate change, on marine organisms
- Conduct experimental assessments of fitness parameters under stress of multiple stressors
- Develop bioenergetics-based models (Dynamic Energy Budget) and mechanistic concepts to predict the influence of multiple factors on the performance of key benthic species
- Organize and conduct scientific meetings
- Publish research results
